**UNMANNED AIRCRAFT SYSTEMS (UAS/DRONE)
OPERATOR'S COMPLIANCE STATEMENT**

1. OUR COMPANY HAS BEEN ISSUED AN EXEMPTION UNDER SECTION 333 OF THE FAA MODERNIZATION AND REFORM ACT OF 2012 (333 EXEMPTION) AUTHORIZING OUR COMPANY TO USE A UAS/DRONE FOR COMMERCIAL PURPOSES.
2. THE SERVICES WE WILL BE PROVIDING TO YOU AS DETAILED IN THE APPLICABLE WRITTEN SERVICE AGREEMENT ARE EXPRESSLY AUTHORIZED UNDER OUR 333 EXEMPTION.
3. THE UAS/DRONE WE WILL USE IS THE SAME UAS/DRONE LISTED IN OUR 333 EXEMPTION AND IT WILL BE FLOWN BY A LICENSED PILOT.
4. WE WILL COMPLY WITH ALL PERMANENT AND TEMPORARY FLIGHT RESTRICTIONS IN EFFECT ON THE DAY(S) AND AT THE LOCATION(S) OF OPERATION.
5. THE UAS/DRONE WE USE WEIGHS LESS THAN 55 POUNDS, WILL NOT BE FLOWN HIGHER THAN 200 FEET, AND WILL REMAIN WITHIN THE SIGHT OF THE PILOT AT ALL TIMES.
6. THE PILOT OPERATING THE DRONE WILL BE OUR OWN EMPLOYEE OR A LICENSED AND INSURED SUBCONTRACTOR.
